 - Potential risk for policy and procedure violation or penalization secondary to moving forward with the program, willingly and knowingly, while out of compliance was not a desirable option.
 - When risk management does occur, the delay, in addition to upcoming holidays, would delay program planning even further into the next calendar year
 - Maybe the chapter needed to regroup and focus on programs that make the most impact on the community and place us in a better standing Regionally and Nationally.
 - Results
 - o The consensus was to forfeit the program this Sorority year
 - Program speakers for the November program at Fayetteville State University were notified of its cancellation

Barriers to Goal Accomplishment

The Membership Committee met Tuesday, November 6, 2018, at the Headquarters Library in Conference Room # 2. The committee discussed the upcoming trip to Greensboro which will be on December 16, 2018. All members who will be attending and riding the bus should be prepared to depart from E.E. Smith High School at 10:00 a.m. We will also be conducting an ornament exchange on the bus. There will be a host of activities planned for the first 13 days of January leading up to our Founders Day. The committee also discussed the possibility of scheduling the Retreat for a location here in town away from the traditional meeting site in order to accommodate those Sorors who will be attending the National Convention. We are looking for a cost effective place to hold this event. We will be taking suggestions from the members, if they know of a place that can accommodate us. I have contacted both the Greek Shop here in Fayetteville and Three Sisters Embroidery, LLC in Durham in regards to the blazers. The Greek Shop's price is \$125.00 per blazer with an ascending price that goes up by size. This blazer will include the official Delta Sigma Theta Crest and the chapter name (if wanted) and can be purchased in either red, black or white. The price for the blazers at Three Sisters Embroidery is a base price of \$105.00 and ascends upwards depending on size. This blazer also includes the official crest and your personal name can be added for an additional \$5.00. The chapter name will be added for free, if more than 6 people order. Three Sisters will also give an additional 10% discount for orders of 4-12 and a 15% discount for orders of 13 or more. There is a 7.75% NC sales tax and shipping fee that will also be added to the cost of the blazers. We will be discussing the details of this project at the December Chapter meeting including the easiest and proper way to determine sizes.
