Chapter Meeting Minutes  
November 13, 2021  
ZOOM Virtual Meeting Platform

Due to the COVID-19 pandemic, the chapter meeting was held via the virtual meeting application of ZOOM.

- A. **Call to Order:** The meeting was called to order at 10:00 am by President Soror Debra Figgins.
- B. **Ritualistic Opening** was conducted per protocol.
- C. **Quorum** was confirmed by Soror Jackie Sherrod, Sargent-at- Arms.
- D. **Adoption of Agenda:** A motion to adopt the agenda was made by Soror Sylvia McPherson, with the following correction: add an “e” to the word *Awareness* in Thrust three: International Awareness and Involvement. The second was given by Soror Paula Frank. With noted correction, the motion carried.
- E. **Adoption of Previous Chapter/Executive Board Meeting Minutes:** A motion to adopt the previous Chapter/Executive Board meeting minutes was made by Soror Sylvia McPherson. The second was given by Soror Barbara Nubin. With no corrections noted, the motion carried.
- F. **Introduction of New and Visiting Sorors:** Soror Amanda Williams. There were no visiting Sorors present. Happy birthday wishes to Sorors celebrating November birthdays. Two trivia questions were asked:
  - a **Who was the Chapter President (of what is now FAC) in 1953?** Answer: Neutrice Wilson Merritt. Answered by Soror Sylvia McPherson.
  - b **Who was the author of “Go Tell It On The Mountain?”** Answer: James Baldwin. Answered by Soror Danita Wilson.
- G. **Financial Secretary’s Report:** Soror Toni Moore reminded Sorors: when sending payments through PayPal, please note *for what* the payment submission is intended. The Fundraising committee will be notified of payment shortages and time will be allowed for correction. Soror Moore confirmed receipts for the month of October. The report was for information only.

- f **Alumnae** is pronounced (*uh-lum-nee*); page 24 of the Protocol and Traditions Manual 2021
- g When saying the Oath, it is “through the **bond** of devotion,” not **bonds**
- h When referencing the National Convention or Regional Conference, there is not an “S” on the end of National or Regional
- i **Camouflage**, with Delta Sigma Theta Sorority, Inc. insignia, is not approved apparel to be worn by Sorors at any time.
- j Sorors were asked to avoid purchasing unauthorized Delta paraphernalia.
- k Two sweaters that have now been approved by HQ were shown to Sorors. Pictures will be shared in FAC Announcement post.

ii. **Program Planning and Development:** Soror Sharon McNair reported that she attended a Community needs assessment meeting. Information will be shared with Thrust Chairs, December 12<sup>th</sup> at 4pm. Soror Brittany McLaurin will present awards. Risk Management training date has been set for 11/14/2021 at 4pm. This training is only for those who work/assist with youth initiatives.

- 1. **Armed Forces:** Soror LaTiki Gray reported that the Armed Forces committee members participated in the Veterans Day Parade. Sorors are asked to participate in Wreaths Across America. Soror Gray will send a link to purchase the wreaths for December 18<sup>th</sup>.

- 3. **Collegiate:** Soror Miller-Bernard reported that as of August 19, 2021, Delta Xi was placed on a *Cease and Desist*. An investigation was held by a regional team. The FAC Advisory team relinquished their roles and Soror Monique King from the Ft. Bragg Area Alumnae Chapter was appointed as the temporary advisor. Madame President asked that Collegiate Connection Committee contact be suspended until further notice. Discussion will be held about continued financial obligations to the collegiate chapter. Madame President will reach out to the Regional Director for further clarification. A robust discussion ensued that resulted in more questions being raised than answers able to be given about "why" the turn of events occurred. A suggestion was made that a meeting should occur to clearly define issues that need

to be addressed with the Regional Director. The actual audience of the meeting was pondered: the former advisors with the President, the former advisors with the Chapter, the perceived lack of transparency if there is a meeting without the Chapter, and the inability of the former advisors to reveal desired answers. Madame President acknowledged she would be receptive to a meeting with the former advisors prior to speaking with the Regional Director and share what information could be shared with the Chapter but cautioned that there may be information that cannot be shared. Regarding the meeting with the former advisors, Madame President preferred not to meet alone, but rather with the Executive Committee present. A motion was made by Soror Teresa Wright that a meeting take place on Monday, November 15, 2021 @ 6:30pm with the former advisors, Chapter President and Executive Committee. The motion was seconded by Soror LaTiki Gray. A vote by poll was called: 88% members voted "Yes" agreeing with a former advisor/President/Executive committee meeting; 12% voted "No" disagreeing with a former advisor/President/Executive committee meeting. The motion carried. Soror Erin White will send the meeting invitation to former advisors, Madame President, and the elected officers of the Executive committee.

**4. Delta Emergency Response Team:** *Emergency Preparedness: Know Your Numbers* PowerPoint and "Sister, Service, and Safety" factsheet will be submitted for dissemination to Sorors.

**5. Finance:** Soror Rayshonia Manuel reminded Sorors that HQ does not allow use of "Friends and Family" with PayPal. Fees are to be paid by the individual Soror. The committee met November 4<sup>th</sup> and discussed creating a flat fee for PayPal. Soror Brothers, National Financial Secretary, was consulted for authorization and stated a flat fee is appropriate.

**6. Fundraising:** Soror Judith Waddell reported that the committee thanks the Sorors for supporting the Building Pyramid Brick by Brick. A presentation was shown of the Sorors/bricks purchased at the different levels thus far. Donations will be accepted until June 2022.
